



State Department Appeasement is Mole Sabotage

From the mid 1950s until today, strong leftist active measures have shaped decision-making within the US State Department and military.

“Active measures” is a Soviet term referring to offensive subversive operations carried out against foreign personnel and organizations, and sanctioned by the highest levels of government.

Active measures operatives intervene in the internal and foreign affairs of target nations in order to mislead them about Soviet (or other totalitarian nation's) activities, capabilities and intentions. In addition, active measures agents seek to distort target nation decision-making towards the creation of policies which benefit the orchestrator of the active measures, or whomever he designates. Such benefits usually contradict the best interests of the target state. The aim is to undermine and

ultimately destroy all power which competes with the active measures manipulator or his friends. Active measures are frequently implemented by defectors in place, who in their hearts and minds have abandoned their former allegiances or betrayed a false commitment to those allegiances to their fatherland. They have become servants of enemies and they are antagonistic to their own nation's best interests.

The Gamut of Active Measures

- Opposition to, and defamation of foreign governments, political parties or important individuals both in particular countries and on the world stage.
- Incitement of populations against state institutions.
- Influencing of mass political opinion
- Active opposition to, and discrediting of, organizations and persons who actively resist the plans/policies of the manipulating nation.
- Disruption of relations between competing states.
- Misrepresentation of any politically related pacts or alliances.
- Acquisition of foreign technology.
- Undermining of foreign intelligence services and/or other bureaucracies.
- Shaping decisions made by foreign organizations towards courses of action benefiting, or convergent with the policy of the manipulating nation.

AGENTS OF INFLUENCE

The chief executors of Active Measures are traitorous stooges known as “agents of influence.” They serve the best interests of enemy nations in league with sympathizers, the mass media, and front organizations existing within a target state. Their tactics include widespread use of deception and the dissemination of false information (disinformation).

Agents of influence are either trained deep penetration agents in the pay of a foreign nation or traitors recruited/developed within the nation they betray. In turn, agents of influence may recruit and manage influential personalities in public life within target nations. “...preferred targets for recruitment are senior government officials, senior political party officials, members of the country’s legislature, widely regarded spiritual figures and journalists.” Many academics also volunteer to serve enemy interests.

For the past sixty-five years, the ruling establishments of western nations such as Britain, the United States, South Africa and Rhodesia have, knowingly or unknowingly, harbored at their very core individuals who operated, under a cloak of great secrecy, as active agents of the Soviet Union. These members of the Hard Left and, at their core, the Ultra-Hard Left are among the most dangerous enemies of humanity extant.

These modern day demons of the left were accurately described by the novelist Frederick Forsyth. "These are dedicated, dyed-in-the-wool Marxist-Leninists, who would not appreciate being called Communists, since this implies membership in the...British (or American) Communist Party. They are, nevertheless, staunch friends of Moscow (or Muslimism) and in nine cases out of ten will act in accordance with Moscow's (Muslimism's) wishes, even though those wishes may remain unexpressed and even though the person concerned would stoutly claim that he was acting for 'conscientious' or 'British' (or American patriotic etc.) reasons..."

The hard left also includes, "those persons with a deep political and emotional commitment to a form of socialism so far left as to qualify as Marxism-Leninism; persons who will, in any given set of circumstances or in any contingency, almost invariably react quite spontaneously in a manner completely parallel to, or convergent with, the desires of Soviet (or North Vietnamese) foreign policy vis-à-vis (America) and/or the western Alliance; persons who need no briefing or instructions whatsoever and who would probably be offended if such were proposed; persons who, wittingly or unwittingly, whether impelled by personal conviction, a warped patriotism, a desire to destroy, a craving for self-advancement, a fear of intimidatory pressure, a sense of their own self-performance, or a desire to move with the herd, will conduct themselves in a manner that suits...(communist)... interests perfectly. They all constitute agents of influence to, the benefit of the Soviet Union (or North Vietnam). "

Such agents of subversion, "claim to be seekers after democracy...Obviously, our Hard Left friends...being people who eat, drink, breathe, sleep, dream, and work at left-wing politics every waking hour of every day, mean by the word democracy a 'democracy of the committed,' with its controlling roles performed by themselves and like-thinkers."

Most American leftist agents of influence during the Vietnam era sympathized with, or remained obedient to, the international policy imperatives of the Soviet Union. They were careful not to entertain any aberrations of the Leninist doctrine of caution and dissimulation. Leftist agents of influence discipline themselves to neither operate too openly nor reveal themselves too visibly. Hard left orchestrated active measures adhered to that "clandestinity demanded by Lenin of true believers operating within a bourgeoisie society."

Agents of influence are simultaneously deception and intelligence assets because they act in two capacities: information collection and situational influence. Agents of influence carry out "active measures" which include a wide variety of influence operations."...While the term 'agent of influence,'

is normally used for individuals engaged in influence operations rather than those who collect intelligence, in some cases the same agents are used for both..."

High status American elites, particularly those members of the "Eastern Establishment" (Ivy League university graduates) seem particularly susceptible to influence agent recruitment overtures. "...To the category of influence agents belong those who occupy important positions in the social hierarchy of an enemy country and by virtue of their position are capable of influencing public life there under the direction of a communist intelligence service. Such individuals may be newsmen, officials of the national bureaucracy, party or organizational functionaries, diplomats, parliamentary deputies, politicians, or employees of intelligence (or armed) services..."
